FIRE SAFETY CERTIFICATE

Certified that the Vidya Public School located at Vidya Bhawan, Bangla Sahib Road, Opp. Kali Mandir, Connaught Place, New Delhi, comprises of Ground + 02 Upper floors, owned/occupied by Vidya Public School was earlier granted FSC by this department vide letter No. F6/DFS/MS/NDZ/2021/School/851 dated 13/10/2021. Now, the premises was re-inspected by the officer concerned of this department on 08-08-2024 in the presence of Ms. Papri Roy (Principal) and found that the said school building has deemed complied with the fire prevention and fire safety requirements in accordance with rule 33 of the Delhi Fire Service Rules, 2010 and that the premises is fit for occupancy of class Group B "Educational Building" Sub-Div. B-I with effect from19.1.08.....2024 for a period of three years in accordance with rule 36 unless renewed under rule 37 or sooner cancelled under Rule 40 and subject to compliance of the conditions under rule 38 of the Delhi Fire Service Rules, 2010 on the conditions printed below.

Conditions for the validity of Fire Safety Certificate:

1. All the fire safety arrangements provided therein shall be maintained in good working conditions at all times.

2. Any loss of life or property due to non functional fire safety measures shall be at the responsibility of

the management.

3. The trained fire fighting staff should be available round the clock.

The compliance with regards to electrical installation, structural stability, set back area, occupancy and any deviation in construction etc. shall be verified from authority concerned.

5. This fire safety certificate may not be treated in any case for regularization of unauthorized

construction, if any.

6. The owner / occupier shall submit a declaration every year in form 'K' provided in the first schedule of Delhi Fire Service Rules 2010. The form is available on www.dfs.delhigovt.nic.in

7. The means of escape such as exits, staircases, passage way, etc shall be kept unobstructed / unlocked

for unhindered evacuation in case of an emergency.

8. The owner/occupier shall apply for renewal of this Fire Safety Certificate to the Director in form 'J' [sub rule (I) of rule 37] along with a copy of this Certificate, six month prior to its expiry.

9. No flammable material shall be used for interior decoration.
